Hi Mike,

Thanks for trying to help me locate disposal information for the general licenses.

We talked about so many that I want to make sure I have them straight. Please take a look at the following and correct me where necessary.

Pfizer - We had two devices listed w/o serial numbers. You have documentation showing one possibly returned. You will send documentation for the one.

Since our conversation, I looked up the Quarterly Report ending September 30, 1989 and it only lists one device transferred to Pfizer in Lock Haven, PA.

Atlas Powder Company - We can not verify disposal of one gauge without more information. Our trackingsystem only has a system number for the model, 3600F. Witout knowing the gauge model number and serial number, disposal documentation can not be obtained.

Bell Trading Company - We have eight devices listed for this licensee without serial numbers. You found a Job number Quote to remove four devices from service. You will look closer at this case and get information to me. The devices listed in our data base are Model 5201,

Cs-137, 100 mCi.

LP Synfuels, Inc. - You still have the one device, Model # 5211, Serial # B0275, listed at the licensee location.

PM Technologies, Inc. - We have two devices listed for this licensee. The devices are listed as system numbers, 4800. No serial numbers are listed. The devices contained CS-137, 100 mCi sources and were listed on a 2nd Quaterly Report from Kay-Ray. You can not locate disposal information for the devices without gauge model and serial numbers. You did find a Speciality Minerals Company located at 40 North 13th Street, Easton, PA.

The following case we did not discuss. Please look at it. I visited the address at Castor Avenue East of Richmaon Street, Philadelphia, PA and found an empty building. The majority of the site is now owned by Philadelphia Gas Company. The two devices could have been returned by either the licensee or Philadelphia Gas Company.

Franklin Smelting & Refining Corporation - We have two devices listed in our inventory. They ar both Model # 7063P an no serial numbers. They each contained Cs-137 500 mCi.
