Dear Mr. Poletti:

By letter dated June 21, 2006, you requested an amendment to NRC Materials License No. 25-19852-01 to remove Building 7 from Condition 21 of the license, as listed in the application dated February 28, 2005. Attached to your letter was a final status survey report for this location of use.

I am writing to notify you that the NRC has initiated a review of the final status survey report. We have conducted an administrative completeness review and have determined that the submittal contains sufficient type and quality of information to begin the in-depth technical review. This completeness review does not reflect the technical adequacy of the information provided. We may periodically request additional information as a result of our technical review.

Based on the information provided in NUREG-1757, Volume 1, Revision 1, "Consolidated NMSS Decommissioning Guidance," your submittal has been initially classified as a Group 2 decommissioning project because you are using NRC-accepted screening criteria and because you have determined that a decommissioning plan is unnecessary. Therefore, your submittal will be processed using the guidance provided in Chapter 9 of NUREG-1757, Volume 1.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's document system (ADAMS), accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
