

The purpose of this modification is to incrementally fund this contract in the amount of \$172,121.02, which will bring the total obligated amount from \$177,951.00 to \$350,072.02. Accordingly the contract is modified as follows:

Refer to Section B.3, entitled "CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991)" paragraph (c) and (d) are hereby deleted in their entirety and replaced with the following:

- "(c) The amount currently obligated by the Government with respect to this contract is \$350,072.02, of which the sum of \$322,647.02 represents the estimated reimbursable costs, and of which \$27,425.00 represents the fixed fee.
- (d) It is estimated that the amount currently allotted will cover performance through November 2007."

A summary of obligations for this contract, from the date of award through the date of this action, is given below:

Total FY2005 Obligations:	\$177,951.00
Total FY2006 Obligations:	\$172,121.02
Cumulative Total of NRC Obligations:	\$350,072.02

The action obligates FY06 funds in the amount of \$172,121.02.
