


The purpose of this modification is to (1) exercise Option Year One of the order to extend the period of performance through May 31, 2007; (2) increase the ceiling amount in the order by \$99,931.85 from \$96,180.80 to \$196,112.65; and (3) add incremental funding in the amount of \$90,000.00, thereby increasing the amount obligated in the contract from \$96,180.80 to \$186,180.80. Accordingly, the order is hereby modified as follows:

1. The period of performance of the delivery is from June 1, 2005 through May 31, 2007. The term of this order may be extended an additional year.
2. The ceiling amount of this order is \$196,112.65.
3. The amount presently obligated with respect to this order is \$186,180.80. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this order. When and if the amounts paid and payable to the Contractor hereunder equals the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer increases the amount obligated with respect to this order. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's risk.

The following is a summary of obligations for this order from the date of award through the date of this action:

FY 2005 Obligations:	\$ 96,180.80
FY 2006 Obligations:	\$ 90,000.00
Cumulative Total of NRC Obligations:	\$186,180.80

This modification obligates FY 2006 funds in the amount of \$90,000.00.

All other terms and conditions remain unchanged.
