The purpose of this modification is to 1) make an administrative change by changing the project officer; 2) obligate funds in the amount of \$1,182.00 to complete the funding for the July 2006 course; 3) exercise option year one to extend the term of the contract through June 20, 2007; and 4) obligate incremental funds of \$39,378.00. Accordingly, the contract is hereby modified as follows:

1. C.13 Project Officer Authority (FEB 2004), paragraph (a) the project officer's name is deleted and replaced with the following: [REDACTED] telephone number 423-855-6519.
2. In accordance with Section C.10, Option Year One is hereby exercised at the prices set forth in the basic contract. The total contract price is increased by \$40,560 from \$67,378 to \$107,938. Section C.17, first sentence, is revised to read, "The ordering period for this contract shall commence on 6/21/05 and will expire on 6/14/07."
