

The purpose of this modification is to deobligate excess funds in the amount of \$16,390.47, thereby decreasing the total amount of funds obligated under this contract from \$334,418.00, to \$318,027.53. Accordingly, the following changes are hereby made:

(1) Under Paragraph B.3 – CONSIDERATION AND OBLIGATION – COST PLUS FIXED FEE (JUN 1988) ALTERNATE 1 (JUNE 1991), Subparagraph (c) is hereby deleted in its entirety and substituted in lieu thereof the following:

“(c) The amount presently obligated by the Government with respect to this contract is \$318,027.53, of which \$293,255.53 represents the estimated reimbursable cost, and of which \$24,772.00 represents the fixed fee.”
