The purpose of this contract modification is to extend the period of performance in Option Period 4 for an additional one (1) month at \$26,347.53/MO. Accordingly, the contract is modified as follows: The total firm fixed price of the contract is increased by \$26,347.53 from \$1,388,645.70 to \$1,414,993.23. Section B.4 is changed to read, "The firm fixed price of this contract is \$1,414,993.23." Section F.2 of this contract is to read, "The contract shall commence on June 18, 2001 and will expire on July 17, 2006." All other terms and conditions remain unchanged.
