


The purpose of this modification is to 1) exercise option period two, 2) Increase the ceiling amount by \$75,552.00 from \$215,769.60 to \$291,321.60 and 3) Increase the obligated amount by \$55,000.00 from \$215,769.60 to \$270,769.60. Accordingly the Contract is modified as follows:

1) Exercise Option Period 1 (July 7, 2006 through July 6, 2007)

Refer to Section XV, entitled "PERIOD OF PERFORMANCE" is hereby deleted in its entirety and replaced with the following:

"Contractor's services shall commence on July 7, 2003 and expire on July 6, 2007. The term of this contract may be extended at the option of the Government for an additional one (1), twelve (12) month optional period."

2) Ceiling

Refer to Section B.2, entitled "CONSIDERATION AND OBLIGATION", paragraph (a) is deleted in its entirety and replaced with the following:

"The total amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$291,321.60. (Includes all exercised options)"

3) Obligations

Refer to Section B.2, entitled "CONSIDERATION AND OBLIGATION", paragraph (b) first sentence is deleted in its entirety and replaced with the following:

"The amount presently obligated with respect to this contract is \$270,769.60".

A summary of obligations for this contract, from the date of award through the date of this action, is given below:

The action obligates FY05 funds in the amount of \$55,000.00.

All other terms and conditions remain the same.
