

The purpose of this modification is to (1) exercise Option Period One in accordance Section C.7, FAR Clause 52-217-9, "Option to Extend the Term of the Contract", thereby extending the period of performance through June 30, 2007 (2) increase the contract ceiling amount by \$18,148.00 from \$17,450.00 to \$35,598.00 (3) provide incremental funding in the amount of \$18,148.00 which increases the obligated amount from \$17,450.00 to \$35,598.00. Accordingly the contract is modified as follows:

1) Refer to Section B.3, "CONSIDERATION AND OBLIGATION--TASKS ORDERS (JUN 1988))", the first sentence in paragraphs (a) and (b) are deleted in their entirety and replaced with the following:

"(a) The total estimated amount of this contract ceiling (Maximum Ordering Limitation) for the products/services ordered, delivered, and accepted under this contract is \$35,598.00.

(b) The amount presently obligated with respect to this contract is \$35,598.00."

2) Refer to Section F.4, "DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987)", the first paragraph is deleted in its entirety and replaced with the following:

"The ordering period for this contract shall commence on August 1, 2005 and will expire on June 30, 2007. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the option of the Government for an additional three 1-year options."

A summary of obligations for this contract, from the date of award through this action is given below:

This modification obligates FY06 funds in the amount of \$18,148.00
