Re: Amendment to Import/Export License CBP0001b

Dear Ms. Doane,

Precision Energy Services, Inc. (Precision), a subsidiary of Weatherford International Ltd.<sup>1</sup>, wishes to amend its multi-country export and import specific license CBP0001b to add an additional authorized location for export & import of its radioactive sources that may exceed the quantities of concern. Specifically we wish to add a licensed third party agent, NSSI of Houston, to directly receive imports from our international locations and possibly export sources on behalf of Precision.

In furtherance of this request it should be noted that NSSI/Sources & Services, Inc. is licensed to perform services, such as Precision is requesting, by the Texas DSHS Radiation Control Program under radioactive material license L02991. NSSI has decades of experience offering these services to both government and industry. NSSI is also licensed by NRC under import license IBP0032. NSSI is the primary point of consolidation of radioactive sources for DOE's Offsite Recovery Project (OSRP), including sources that are being imported from international locations in conjunction with DOE's NNSA group. Note that Precision is also simultaneously requesting an identical amendment to its CBP0001a license by a separate amendment request letter.

We are enclosing a check in the amount of \$300, that being the amount specified for in 10 CFR 170.31, Category 15. E. for a minor amendment to existing import/export licenses and this amount was also confirmed by Tonya Russell of NRC OIP.


