The purposes of this modification are to: (1) correct the price of the line items to be based on the actual MOBIS schedule labor rate versus a rounded labor rate that was accidentally used in the original cost proposal. The correct rate for the Senior Manager is \$267.91. The correct rate for the Senior Consultant is \$177.54. The correct rate for the Associate is \$131.66; (2) exercise optional line items CLIN 2E (Option 1E) ; CLIN 2F (Option 2F); CLIN 2G (Option 1G); CLIN 2H (Option 1H); CLIN 3: Option 2; and CLIN 4: Option 3; and (3) extend the period of performance. Specific changes to the purchase order is as follows:

1. The Cost Price Schedule is hereby deleted in its entirety and replaced with the attached Cost Price Schedule.
2. Optional line items: CLIN 2E (Option 1E) ; CLIN 2F (Option 2F); CLIN 2G (Option 1G); CLIN 2H (Option 1H); CLIN 3: Option 2; and CLIN 4: Option 3 are hereby exercised.
3. Contract Section A.2 entitled, "Duration of Contract Period (MAR 1987)" is hereby deleted in its entirety and replaced with the following:

This contract shall commence on October 1, 2005 and will expire on March 30, 2007.

4. This modification obligates \$42,868.64 in FY 2006 funds. Therefore, the total amount obligated for this purchase order is increased from \$51,090 to \$93,958.64.
5. The total cost for Base and all Options is decreased by \$281.36 from \$94,240.00 to \$93,958.64.
6. All other terms and conditions of the purchase order remain the same.
