The purpose of this modification is to provide incremental funding in the amount of \$40,000. Accordingly, the following change is made:

Section A.2. CONSIDERATION AND OBLIGATION, Paragraph (B) is revised to increase the obligated amount by \$40,000 from \$850,000.00 to \$890,000.00. Therefore, the first sentence of Paragraph (B) is revised to read as follows:

"(B) The amount presently obligated with respect to this order is \$890,000."
