

The purpose of this modification is to extend the delivery date for the completed and SITSO-approved self-assessment deliverables at no additional cost to the Government, and to clarify the delivery date for the trend analyses deliverables. Accordingly, the following changes are hereby made (note: changes are in italics):

(1) SOW Section 8.0, Paragraph 4, is deleted in its entirety and replaced with the following:

"The Contractor shall provide security analyst support to develop all requisite AISSS documentation such that all 34 final Major Application and General Support Systems AISSS reports have been completed, approved by the NRC Senior Information Technology Security Officer (SITSO), and accepted by the NRC Project Officer by no later than *July 19, 2006*."

(2) SOW Section 9.1, Paragraph 1, is deleted in its entirety and replaced with the following:

"All deliverables shall be delivered no later than *July 19, 2006*. Deliverables are to be transmitted with a cover letter, on the Contractor's letterhead, describing the contents and identifying contract/order number and title."

All other terms and conditions of the subject delivery order remain unchanged.
