Subsystem - due June 21, 2006  
Perform Testing on Phase 2 - July 12, 2006  
Completion of Phase 2 Testing - July 12, 2006

PHASE 3: Load Workforce Analysis Formal Complaints  
Subsystem - due July 19, 2006  
Perform Testing on Phase 3 and  
Completion of Phase 3 Testing - August 9, 2006

PHASE 4: Production, Certification and Accreditation - projected completion  
is October 13, 2006"
