The purposes of this modification are to: (1) Confirm verbal authorization that was provided to Grant Thornton on 4/28/2006, effective 4/28/2006, to extend the period of performance of the task order to May 15, 2006, at no additional cost to the Government; (2) Extend the period of performance again to May 22, 2006, at no change to the ceiling price of \$1,174,399.86, in order to allow time to negotiate the cost to complete the task order and reach a mutual agreement on due dates for the remaining deliverables; and (3) Provide incremental funds in the amount of \$10,000.

As a result of this modification, the total amount obligated for the task order is increased by \$10,000, from \$992,390 to \$1,002,390.

The total ceiling price of the task order remains unchanged at \$1,174,399.86, as well as all other terms and conditions of the task order.
