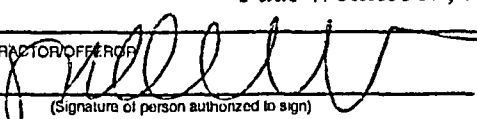
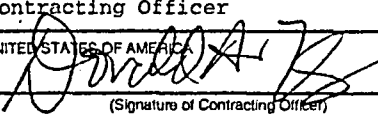

The purposes of this modification are to: (1) definitize verbal authorization that was provided to Grant Thornton on 5/22/2006, effective 5/22/2006, to continue work under the task order with a temporary ceiling of \$10,000; (2) revise delivery due dates; (3) extend the overall period of performance; (4) increase the price ceiling by \$35,623.66, from \$1,174,399.86, to \$1,210,053.52 due to the complexity of the project and Government reviews taking longer than anticipated; and (5) provide funds to fully fund the task order.
