

Accordingly, the purchase order is modified as follows: The period of performance is revised to read: 02/01/2006 to 07/12/2006. The hours are increased by 216 from 320 to 536 hours. The ceiling and obligated amount are hereby increased by \$16,344.72 from \$24,214.40 to \$40,559.12. All other terms and conditions of this purchase order remain the same.
