

Refer to Task Order No. 002 entitled "HLW - LAN/WAN Load Testing" dated August 19, 2005, and further modify the order to extend the period of performance through 5/15/2006 at no additional cost to the Government, per your email dated 3/15/2006. This no cost extension is required due to delays in the HLW project timeline, and in the implementation of the necessary software by the NRC Regions. Accordingly, Task Order No. 002 is modified as follows:

- Corrects the modification number reflected in the previous modification dtd 11-01-2005 from M002 to "M001".
 - "Task Order No. 002 shall be effective July 25, 2005 through May 15, 2006 with a total cost ceiling of \$181,410.22."
 - THE PERIOD OF PERFORMANCE reflected in the SOA is revised to read: "July 25, 2005 through May 15, 2006."
- CEXEC shall bill NRC the discounted GSA rates applicable per period, as negotiated under 10/10 Delivery Order No. DF-33-05-345.
