Reference Contract NRC-02-05-002, Task Order 1, entitled "Technical Assistance for Supporting Documents and Tasks Associated with the Rulemaking to Revise the Definition of Byproduct Material," period of perf. 11/28/05 - 07/31/08. The purpose of this modification is to add incremental funding in the amount of \$70,000.00, thereby increasing the obligated amount of this task order by \$70,000.00, from \$50,000.00 to \$120,000.00.
