Dear LAT:

Pittsburgh Cardiovascular Institute wishes to amend its Radioactive License number 37-21012-01. The amendments requested are to satisfy new Highmark BC & BS credentialing requirements for physicians providing nuclear imaging services to Highmark Keystone Health Plan West member subscribers. Specifically:

- A. The organization seeking credentialing with Highmark must have the name on the application match exactly with the name listed on the Radioactive Materials License.
- B. Each practice address where testing is performed with radioactive isotopes must be listed on the NRC license.

To comply with Highmark's new credentialing guidelines aforementioned in item A, please change the licensee on License number 37-21012-01 from "Pittsburgh Cardiovascular Institute, dba Med Health Services". The amendment in the licensee is to more accurately demark the legal organization associated with the license. The organization, Oliver W. Caminos, M.D., is a sole proprietorship with established dba's (Pittsburgh Cardiovascular Institute and Med Health Services) for insurance credentialing purposes. Please be advised that this change is not because of bankruptcy or a change in ownership. This change is being requested because the licensee currently listed on the license does not match the organization name that is re-credentialing itself with Highmark.

To comply with Highmark's new credentialing guideline aforementioned in item B, please replace in condition 10 of license number 37-21012-01 the following locations as temporary place of use job sites current as of July 17, 2006:


