Dear Mr. Stall:

In a telephone conversation on July 19, 2006, between Mr. Gregory Laughlin, Operations Initial Licensing Training Supervisor, and Mr. Ronald F. Aiello, Senior Operations Engineer, arrangements were made for the administration of licensing examinations at your Turkey Point Nuclear Plant. The operating test is scheduled for the period of January 22 - February 9, 2007. The written examination is scheduled to be administered on February 12, 2007. The on-site preparatory week is scheduled for the week of January 8, 2007.

As agreed during the telephone conversation, your staff will prepare both the written examination and the operating test based on the guidelines in Revision 9 of NUREG-1021, "Operator Licensing Examination Standards for Power Reactors." The NRC regional office will discuss with your staff any changes that might be necessary before the examinations are administered. Your staff has also agreed to make all copies of the examination materials prior to administration.

To meet the above schedule, it will be necessary for your staff to furnish the operating test outlines by October 23, 2006. The supporting reference materials identified in Attachment 2 of ES-201, the written examination and the operating test will be due by November 27, 2006. Pursuant to 10 CFR 55.40(b)(3), an authorized representative of the facility licensee shall approve the outlines, examinations, and tests before they are submitted to the NRC for review and approval. All materials shall be complete and ready-to-use. We request that any personal, proprietary, sensitive unclassified, or safeguards information in your response be contained in a separate enclosure and appropriately marked. Any delay in receiving the required examination and reference materials, or the submittal of inadequate or incomplete materials, may cause the examinations to be rescheduled.

In order to conduct the requested written examinations and operating test, it will be necessary for your staff to provide adequate space and accommodations in accordance with ES-402, and to make the simulation facility available on the dates noted above. In accordance with ES-302, your staff should retain the original simulator performance data (e.g., system pressures, temperatures, and levels) generated during the dynamic operating tests until the examination results are final.
