The purpose of this modification is to: (1) exercise option year one in accordance with Federal Acquisition Regulation Clause 52-217-9, entitled, "Option to Extend the Term of the Contract," and Contract Clause B.17, entitled, "Period of Performance," thereby extending the term of the contract through July 31, 2007. As a result of this action, the contract ceiling amount is increased by \$715,062.00 from \$2,103,512.00 to \$2,818,574.00, and (2) obligate FY'06 funds in the amount of \$160,000.00, thereby increasing the obligated amount of the subject contract from \$2,103,512.00 to \$2,263,512.00.

Accordingly, the following changes are hereby made:

1. Subsection B.17, "Period of Performance," is deleted in its entirety and substituted with the following in lieu thereof:

"PERIOD OF PERFORMANCE

This contract shall commence on August 1, 2003, and will expire on July 31, 2007. The term of this contract may be extended at the option of the government for an additional one-year period."

2. Subsection, "B.24 Consideration and Obligation," is deleted in its entirety and substituted with the following in lieu thereof:

"CONSIDERATION AND OBLIGATION

- (a) The total estimated cost to the Government for full performance under this contract is \$2,818,574.00.
- (b) The amount currently obligated by the Government with respect to this contract is \$2,263,512.00.
- (c) It is estimated that the amount currently allotted will cover performance through October 31, 2006."

A summary of obligations for this contract from award date through the date of this action is given below:

This modification obligates FY'06 funds in the amount of \$160,000.00.

All other terms and conditions under this contract remains unchanged.
