SUBJECT: PLANNED REORGANIZATION OF THE NUCLEAR REGULATORY
COMMISSION OFFICE OF NUCLEAR MATERIAL SAFETY AND
SAFEGUARDS AND THE OFFICE OF STATE AND TRIBAL PROGRAMS

Dear Mr. Toelle:

The U.S. Nuclear Regulatory Commission (NRC) is merging the Nuclear Materials Safety and Safeguards (NMSS) Divisions of Industrial, Medical and Nuclear Safety and Waste Management and Environmental Protection with the Office of State and Tribal Programs (STP) to create a new Office of the National Materials Program. Concurrently, we are consolidating the roles of the NMSS Divisions of High-Level Waste Repository Safety, Spent Fuel Program Office, and Fuel Cycle Safety and Safeguards (FCSS) into a reorganized Office of NMSS. Additional information will be available on the NRC web site as organizational details are developed. This reorganization is scheduled to take effect on October 1, 2006.

NMSS and STP currently support the agency's mission to protect public health and safety by regulating a diverse range of activities involving the use and handling of radioactive materials, including: uranium recovery, conversion, enrichment and fuel fabrication; medical, industrial, academic, and commercial uses of radioactive materials; transportation, including certification of transport containers, spent fuel storage, safe management and disposal of low-level and high-level radioactive waste; and management of decommissioning of reactor and materials facilities. The intent in reorganizing now is to ensure that our organizational structure will enable us to meet the safety and regulatory challenges presented by: evolving technologies associated with the above activities; the projected increase in needed nuclear fuel to support proposed new reactor plant operations here and abroad; and new regulatory responsibilities that may arise from the Nation's Global Nuclear Energy Partnership.

As part of the above reorganization, FCSS will acquire responsibility for Material Control and Accountability from the Office of Nuclear Security and Incident Response. While this change may result in some changes in organizational structure within FCSS, it will not affect your interface with myself or other Project Managers. The consolidation of roles in the reorganized NMSS is intended to sharpen the organizational focus and provide more effective support of Project Managers in conducting regulatory and safety reviews in response to your needs and requests. One of our most important objectives is to maintain our focus on the safety of existing facilities while we conduct regulatory and safety reviews of new technologies and facilities.
