**OPPORTUNITY TO COMMENT ON PROPOSED NARM RULE AND ENVIRONMENTAL  
ASSESSMENT (RIN 3150-AH84) (STP-06-068)**

**Purpose:** To transmit: 1) the proposed rule on the expanded definition of byproduct material (NARM rule); and 2) the environmental assessment. The EA and *Federal Register* notice are provided for your review and comment.<sup>1</sup>

**Comment period:** Any comments on the rule and its environmental impact should be submitted within 45 days (September 11, 2006). If you have any comments specific to the information collection aspects of the rule, please submit them within 30 days (August 27, 2006). Comments received after these dates will be considered if it is practical to do so, but the Commission is able to assure consideration only for comments received on or before the indicated dates.

**Summary:** The United States Nuclear Regulatory Commission (NRC) sent to the Office of the Federal Register, for publication, the proposed amendments to the Commission's rules in 10 CFR Parts 20, 30, 31, 32, 33, 35, 50, 61, 62, 72, 110, 150, 170, and 171. The proposed rule was noticed in the *Federal Register* today (71 FR 42952, dated July 28, 2006). The portable document format (PDF) file is also enclosed for your convenience.

These amendments were developed to comply with Section 651 (e) of the Energy Policy Act of 2005, and they would establish the regulatory framework for regulating discrete sources of radium-226 and accelerator-produced radioactive material for commercial, medical, or research use. The proposed rules would revise the definition of "byproduct material" and add a definition for "discrete sources," as required by the Energy Policy Act of 2005. The proposed rules would also amend portions of the existing regulations and add certain provisions for regulating discrete sources of radium-226 and accelerator-produced radioactive material.

Also enclosed is an Environmental Assessment (EA) that has been prepared in support of the proposed rules. The EA's conclusion is the Commission's finding that no significant environmental impact will result from the proposed rules.
