The Texas Department of State Health Services (DSHS) submits the following comments supporting the proposed change for the National Source Tracking System (NSTS) rulemaking for Category 1 and 2 radioactive sources.

DSHS supports the issuance of this rulemaking under Category B, Public Health and Safety compatibility designation for the following reasons:

1. This change would eliminate the dual regulation of Agreement State licensees under this rule.
2. As an Agreement State, DSHS' Radiation Control Program has demonstrated its ability to work cooperatively with radioactive materials licensees in Texas and this relationship will assure the validity of source accountability under the NSTS rules.
3. Accountability of radioactive sources is a function of health and safety.
