Dear all:

I have been assigned to review the Salem/Hope Creek OI report Alleged Discrimination for Raising Safety Issues with the Chief Nuclear Officer and the PSEG Chairman of the Board. My completion date is this Friday (1/13). The Report has been very useful. I have not delved into the Exhibits. I have also discussed the OI report with Karl and with Russ Arrighi.

The first thing I wanted to accomplish was to set up a discussion with Jeff Teator so that I could discuss the investigation with him. Russ would also definitely want to participate. Karl had made this suggestion. Then he checked on Jeff's schedule and was advised (see below) that he was out on an investigation through tomorrow (Thursday) morning. Ernie: do you have any more precise information that would enable a determination whether Ernie would be available and ready to support such a discussion this week? Also, can you contact Jeff about it so that we will not "hit him cold" on this. I am in the office tomorrow and Friday and do not have any meetings on my schedule. A discussion this week is important to meet my due date.

Also, my availability to call in to an enforcement board on Wednesday, 1/19 is doubtful. I will be in a meeting between NRC and USEC at Portsmouth most of the day and will then be returning to the Columbus, Ohio airport. I owe Janice Moore a briefing on the OI report by this Friday.

I would appreciate a discussion this week, the necessary persons being available. Try to set it up. Your efforts will be appreciated.
