Dear Mr. Mr. J. A. Stall:

On May 19, 2006, the U. S. Nuclear Regulatory Commission (NRC) completed the security baseline inspection at your St. Lucie Nuclear Power Plant Units 1 and 2. Portions of inspection procedures 71130.01, Access Authorization, and 71130.08, Fitness for Duty, were completed at the FPL Corporate Office on May 12, 2006. The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report documents the inspection results, which were discussed with Mr. D. Bonthron, at the corporate office, on May 12, 2006, and with Mr. G. Johnston, at the St. Lucie Nuclear Power Plant and other members of your staff on May 19, 2006. A re-exit was conducted on June 29, 2006, with Mr. B. Jacques, and other members of your staff.

This inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

This report documents two findings of very low significance (i.e., Green as determined by the Physical Protection Significance Determination Process). The deficiencies were promptly corrected or compensated for, and the plant was in compliance with applicable physical protection and security requirements within the scope of this inspection before the inspectors left the site.

NRC is treating these violations as non-cited violations (NCVs) consistent with Section VI.A.1 of the NRC Enforcement Policy because of the very low security significance of the violations and because they are entered into your corrective action program. If you contest these non-cited violations, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN.: Document
