I appreciate your interest in conducting a meeting to discuss New Jersey's intent to enter into an Agreement with the U.S. Nuclear Regulatory Commission (NRC) under Section 274b. of the Atomic Energy Act of 1954, as amended. To date, 34 States have signed Agreements with the NRC, by which those States have assumed regulatory responsibility over certain byproduct, source, and small quantities of special nuclear material. The Commonwealths of Pennsylvania and Virginia are also currently pursuing Agreements with the NRC.

This letter is to confirm that a meeting to discuss New Jersey's intent to become an Agreement State is scheduled for September 18, 2006, at your offices at 401 East State Street in Trenton, New Jersey. The meeting is anticipated to last the majority of the day. Enclosed for your review is a draft agenda for the meeting, of which we welcome your comments.

Mr. Aaron T. McCraw, of my staff, has been assigned as the NRC Project Manager for assisting your State in the process of becoming an Agreement State.
