See attached note from Ernie Wilson indicating that a key PSEG Human Resources individual in the subject case has now [REDACTED] - this is the discrimination case that OI issued on December 28, 2004 as unsubstantiated. We are planning to take to an ARB next week.

I previously spoke with Jim Luehman, OE, about having HQ participation (OE, NRR, and OGC) in the ARB, given the sensitivity of this case. {Jim - please pass this note and the attached to those in HQ with a need to know and who will be participating in the ARB}. Dave Vito will be scheduling the ARB for sometime next Wednesday 1/19.

The individual who alleged discrimination also raised (1) SCWE issues (previously address and closed with her in a previous status letter) and (2) [REDACTED]

[REDACTED] Therefore, Dave Vito has suggested that at next weeks' ARB on the unsubstantiated discrimination issue, we should discuss whether it may be appropriate to issue the results of both cases at the same time.
