

## PSEG / Allegation Project Plan

### March 18 Management Meeting

- NRC approach -  
Region I managers to visit site early, including some staff interviews, then meeting preparations onsite. No briefing package.
- PSEG approach - [redacted] letter to encourage some staff attendance

No transcription, but given Lochbaum's videotaping, PSEG will audiotape and provide us a copy.

### Allegation Review

- Status of interviews - summary on G:\Br.3\ARB Docs\Interview Summary
- Transcript review as of March 5 - at least 5 man-weeks of effort remain  
54 interviews done, 25 transcripts reviewed, 19 binned; DRP to pursue 3 man-weeks or more of add'l help.
- Binning - Target to be done by mid-April; on S:\Salem-HC SCWE
- Status of civil action on discrimination - still in discovery process
- Status letter to allegor -  
Status letter (180 days) due mid-April; any discussion of wrongdoing will be carefully addressed in letter so as to not jeopardize OI investigation.  
OI will concur in letter.
- Specific technical issues within transcript -  
Evaluate for allegation entry; some followup inspection may subsequently be done. Preliminary review to be done by next panel to address allegation process vulnerability.
