Can you confirm that our investigators even asked about issue documentation (I get that the interviewees didn't raise it, but did the interviewers?).











I had the same question and had to ask the OI investigator and other SCWE review interviewers about this last week. I knew that a (single) Notification had been written about the incident itself, but didn't see evidence of a flurry of additional Notifications. In the initial formal interview and during other discussions  *7C*

In my discussions w/OI and the SCWE interviewers last week, I could not obtain a definitive answer as to how these additional Notifications (if they indeed were written) manifested themselves within an internal process. What I was definitively told was that right after the event, management did realize and acknowledge the multiple concerns voiced by  *7C*
 was also told that nearly all of the cognizant/affected  were interviewed during the course of the SCWE review, and that none of them complained about how the incident was (or wasn't) documented, or indicated that they had lodged a concern, in whatever fashion, that was blown off. From that information, I crafted the paragraph for Rick Urban to include in the letter (below). At this point, I'm not sure what further benefit we could gain by stopping the presses and doing a more in depth review of this piece. I would welcome any suggestions you may have. *P4*

"Regarding your comments about the documentation of  concerns with respect to this event, we note that the large majority of the  cognizant of this event were interviewed by OI investigators and/or NRC Region I technical staff either as part of  or during the Salem SCWE review. During the course of the  interviews, no one took issue with the documentation of concerns related to the event. It was obvious from the interviews that  had concerns about the actions of the , and that management was aware of their concerns. *7C*


