Summary:

This record represents a series of e-mail and telephone communications on the above dates.

The most recent documentation of Dr. Brown's listing on another license for the requested use is his submitted University of Vermont permit from 1977 [which is unsigned and not on letterhead]. I spoke with Tom Kellogg of the U Vt Radiation Safety Office (802-656-3283) who confirmed that Dr. Brown was an authorized user for radiopharmaceutical therapy in 1977.

Per discussion with Pam Henderson, Medical Branch Chief, we can consider accepting under 10 CFR 35.57 an authorized user from 1977 with 1968 board certification in therapeutic radiology (would have been acceptable under Subpart J) if they provide a compelling amount of credible recent training and experience to demonstrate compliance with 10 CFR 35.59. I asked Sandy Wolff to show that Dr. Brown's recent training/experience is compelling by providing additional documentation, including: dates and locations of the three Zevalin treatments; whether Sandy had the opportunity to observe Dr. Brown's participation in the Zevalin treatments, a description of any training Sandy had provided to him, and an assessment of her confidence in his abilities; whether Dr. Brown has had recent supervised participation in any Sr-89 Metastron, Sm-153 Quadramet, I-131 MIBG, or I-131 Bexxar treatments; and whether he has attended any recent CME sessions or vendor training on therapeutic use of unsealed radiopharmaceuticals.

On August 1, Sandy said the licensee is withdrawing the current request to add Dr. Brown as an authorized user. They may choose to resubmit in the future.

Action Required:

Void the request to name Dr. Brown as AU; continue reviewing the remaining issues for this mail control number.
