Summary:

This record represents a series of e-mail and telephone communications on the above dates.

- a) **Clarify the sentence: "Please change Strontium-90 eye applicator in item 6G and 9E to storage only." Should this be "6E and 9E," or do you wish to place both 6E and 6G (Sr-90 calibration source) into storage?** Sandy said the request is to place into storage-only status two Sr-90 sources, both the eye applicator and the calibration source.
- b) **What are the disposal plans for these sources?** Sandy said she is researching disposal options, however availability of funds will be an issue.
- c) **Who should be listed as non-medical user for supervision of storage?** Sandy said that she will supervise storage.
- d) **You asked to be released from license commitments involving information that was not required to be submitted during the renewal process. You asked to remove Item 10 of the renewal application, except for 10.11 and 10.15. It does not appear that 10.11 and 10.15 were required to be submitted.** Sandy asked to modify the request to remove all of Item 10.

[The request to restore Dr. Zabell's requested IVB authorization is a followup item from the 2006 inspection. The inspectors noted that Dr. Zabell, the primary radiation oncologist at this site, was not listed as an IVB AU. The licensee showed the inspectors a copy of the original amendment request to add IVB, dated 12/7/00. The inspectors, Gabriel and Hott, determined that Dr. Zabell was the only proposed IVB AU, and did meet the requirements based on authorization for 35.400 plus vendor training. At that time, it apparently was standard Region II practice not to specifically list IVB AU's and AMP's on licenses. In Amendment 35 when new IVB authorized individuals were added and the license was updated to the new Part 35/volume 9 format, Dr. Zabell's name was inadvertently omitted from the specific listing of IVB AU's. The licensee did not recognize this error and inadvertently continued it in their renewal request. As requested by licensee management in mail control 138965, Dr. Zabell's user authorization is being updated to include IVB.]

Issue the amendment.
