Reference: Letter from R. M. Krich (UniStar Nuclear) to U.S. NRC, "UniStar Nuclear, NRC Project No. 746, Pre-Application Submittal of the Quality Assurance Program Description," dated July 31, 2006

UniStar Nuclear submitted Revision 0 of its proposed Quality Assurance Program Description (QAPD) for NRC review as an enclosure to our letter dated July 31, 2006 (Reference). This document describes the Quality Assurance (QA) Program covering the activities of siting; design; construction, including pre-operational testing; operation, including testing; maintenance; and modification of a U.S. Evolutionary Power Reactor (EPR).

The purpose of this letter is to correct an oversight in that the QAPD document submitted by our letter of July 31, 2006, is a Topical Report (TR) as described in the NRC's NRR Office Instruction, "Processing Requests for Reviews of Topical Reports," LIC-500, Revision 2. The QAPD meets the four criteria in LIC-500 for the NRC to accept it for review. Specifically, the QAPD 1) deals with the specific safety-related subject regarding a nuclear power plant QA program that requires a safety assessment by the NRC staff, 2) the QAPD will be referenced in the reference- and subsequent-Combined License (i.e., COL) applications (i.e., R-COLA and S-COLAs) for U.S. EPRs, 3) the QAPD contains complete and detailed information on the QA Program, and 4) NRC approval of the QAPD will increase the efficiency of the review process for the R-COLA and S-COLAs that will reference the QAPD.


