(b) The amount presently obligated with respect to this delivery order is \$538,814.00 ..." ALL OTHER TERMS AND CONDITIONS REMAIN THE SAME, INCLUDING THE CEILING AMOUNT OF \$700,011.00 This modification obligates FY2006 funds in the amount of \$302,814.00.
