The purpose of this letter is to acknowledge receipt of your letter dated July 31, 2006, in which you documented completion of the final action you were required to perform in accordance with the Letter of Reprimand and Confirmatory Order Modifying License issued to you by the U.S. Nuclear Regulatory Commission (NRC) on July 14, 2005. This action consisted of making a presentation at a meeting of the Professional Reactor Operator Society.

Previously, in a letter dated October 22, 2005, you documented completion of other actions you were required to perform. Since you have completed all actions required by the Confirmatory Order, the NRC plans no further action regarding this matter.
