This Amendment adds the new manual brachytherapy facility as requested to enable you to move your licensed activities. Prior to release of your facility at 687 North Church Street for unrestricted use, you must receive an Amendment removing the facility from your license. Include in the amendment request, the results of surveys demonstrating that the levels of residual activity in the facility are acceptable. When you submit the Amendment request, please refer to the Control Number at the top of this letter.

As confirmed with Mr. Sam Payne, your consultant, on August 14, 2006, the model number for the sealed sources requested has been listed as STM1251.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

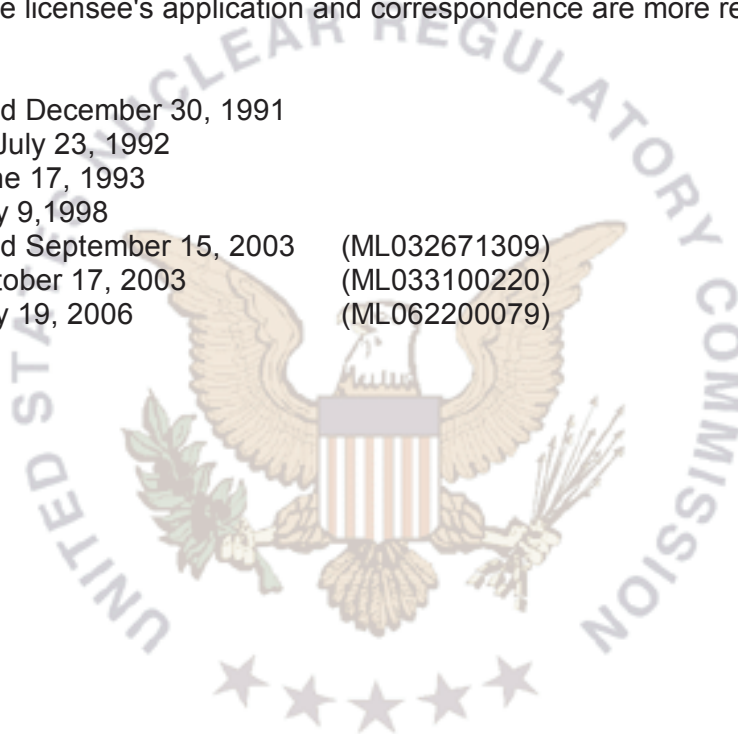
