SUBJECT: CORRESPONDENCE FROM MR. WALSTON CHUBB

Mr. Walston Chubb of Murrysville, PA, sent a letter to Chairman Klein, dated June 29, 2006. In his letter, Mr. Chubb expressed concern that the U.S. Nuclear Regulatory Commission (NRC) is over regulating public exposure to ionizing radiation and this over regulation has caused the NRC to stop processing new orders for nuclear power plants since October 1973. Since March 2003, Mr. Chubb has sent eight additional letters on this specific issue. Mr. Chubb's subsequent letters do not contain new information.

The Offices of Nuclear Reactor Regulation (NRR) and Nuclear Regulatory Research (RES) responded to his letters and explained NRC's radiation safety regulations. The latest response from RES to Mr. Chubb, dated June 28, 2006 (ML061730009), was a letter simply acknowledging receipt of his letter. In that response, the staff noted that NRC will consider his views in our ongoing regulatory research program related to the health effects of ionizing radiation. Letters from Mr. Chubb have been placed in ADAMS, however, RES does not plan to prepare another agency response unless he submits significant new information on this or a new topic.

I recommend that Office of the Secretary reply to Mr. Chubb with a standard acknowledgment letter if such a letter has not already been issued, including language such as "We have previously communicated with you numerous times and understand your views on this matter."
