ORDER  
(Denying Motion to Quash Cook Subpoena)

The Board received last evening, from the parties to these enforcement proceedings, replies to the August 3, 2006 motion filed by mail on behalf of Rodney M. Cook to quash the subpoena -- issued by the Board Chairman on July 11 at the behest of the NRC Staff -- requiring him to appear for a deposition this coming Monday, August 21. In light of the NRC Staff's expressed willingness to accommodate Mr. Cook as to the location of the deposition, we find the reasons proffered for quashing the deposition to be insufficiently persuasive to grant the motion.

To be sure, it may turn out that Mr. Cook will choose to exercise his Fifth Amendment privilege against self-incrimination as to some, if not all, of the questions posed during the deposition. But the Staff has represented that, applying governing legal standards regarding invocation of the privilege, the deposition may nonetheless yield some information relevant in these proceedings. Importantly, Mr. Miller also wants the deposition to proceed, representing

that Mr. Cook may be “the only reliable source” of certain information important to Mr. Miller’s defense. We also note that, unlike another situation in which we will soon be called upon to rule, there is not pending against Mr. Cook any civil enforcement proceeding in which it might be argued that any refusal to testify herein should result in the drawing of negative inferences.

Accordingly, the motion to quash Mr. Cook’s subpoena in toto is DENIED, conditioned upon the deposition being held at the location of Mr. Cook’s choosing. The subpoena previously issued shall be deemed modified to reflect that location in the event any change in location is determined too late to allow us to issue an amended subpoena. Similarly, the subpoena shall, if necessary, be deemed modified to reflect any subsequent agreement among the parties as to a change in time of, or conditions governing, the deposition.

It is SO ORDERED.
