On June 20, 2006, U.S. Nuclear Regulatory Commission (NRC) and USEC Inc. (USEC) staffs held a telephone conference to discuss decommissioning funding issues related to the American Centrifuge Plant.

Discussion:

On June 5, 2006, USEC staff provided revised cost estimates for dispositioning depleted uranium to be generated by the American Centrifuge Plant. In these estimates, USEC staff updated costs to 2006 dollars using de-escalation information presented in the U.S. Department of Energy (DOE) consultant's report of depleted uranium disposition costs. These de-escalation costs had originally been used to de-escalate 2008 dollars to 2004 dollars and were based on expected inflation factors. In the telephone conference call, NRC staff requested that USEC use actual inflation rates rather than the projected rates from the DOE report. NRC staff suggested that the actual Implicit Price Deflator values be used to escalate the estimated costs from 2004 to 2006 dollars. USEC staff agreed to revise the inflation factors using actual values rather than the projected values.

NRC staff also requested that the same changes be included in revisions to the Gaseous Diffusion Plant decommissioning funding plan, which was also being reviewed by NRC staff.
