Licensee should assure that Dr. Desai receives vendor- or vendor-equivalent training before independently performing the duties of HDR AU.</p> <p>2) Additional information is needed to show that Craig Marsden, Ph.D. meets the requirements of 10 CFR 35.51 to be named as authorized medical physicist (AMP). If he has been listed as HDR AMP on the NY radioactive materials license for White Plains Hospital (or on any other license), please submit a copy. Otherwise it is necessary to submit detailed information to show that Dr. Marsden meets the requirements of 10 CFR 35.51(b)(1) and (c), along with a preceptor attestation that includes the elements required by 35.51(b)(2).</p> <p>I asked Bob to let me know whether the licensee plans to submit a copy of a license showing Dr. Marsden listed as AMP for HDR, submit detailed information required by 35.51, or withdraw the request.</p> </div>
