If we do not receive a reply within 30 calendar days from the date of this e-mail, we will assume that you do not wish to pursue your application.

1) Item 2 of your request asks to name Catherine Large as Authorized Medical Physicist (AMP) for your high dose rate remote afterloader (HDR) unit. Please provide the following additional information to support this request:

- a) Copy of a transcript from Ms. Large's M.S. degree from the University of Tennessee.
- b) Statement from Mr. John Li of the range of dates for Ms. Large's one year of full time work experience under his supervision.
- c) For Ms. Large's medical physics residency program: description of the program, confirmation from Dr. Chester Ramsey that he supervised Ms. Large for a minimum of one-year full-time medical physics work experience, and a copy of a Tennessee radioactive materials license listing Dr. Ramsey as an AMP for HDR (if this is a broad license that does not list individual names, also provide a copy of Dr. Ramsey's permit authorizing him as an AMP).

2) Item 3 of your request asks to change the licensee name to "Radiation Oncology, Summit Cancer and Hematology Services." Your license was issued in 2005 under the name "Summit Cancer Services." If a transfer of control has taken place, it is necessary to provide the information listed in Appendix F of NUREG-1556, Vol. 15 (available on the NRC public website at <http://www.nrc.gov/reading-rm/doc-collections/nuregs/staff/sr1556/v15/>). The definition of "control" and "change of control" are discussed on page 5-1 of this NUREG and examples are given in Appendix D.
