Dear Mr. Owens:

This refers to the unannounced, routine health and safety inspection conducted by Nancy A. Farrington of this office on July 20, 2006, of activities authorized by the State of Iowa under reciprocal recognition of U.S. Nuclear Regulatory Commission Radioactive Materials License No. 22-20271-01. The inspection also examined the items that American Engineering Testing, Inc. has implemented for temporary job sites to comply with the new "Increased Controls for Licensees that Possess Sources Containing Radioactive Material Quantities of Concern" as required 641-40.54(136C). The findings were discussed with Clair Christians and you at the conclusion of the inspection.

The inspection was an examination of activities conducted under your license as they relate to radiation safety and security, compliance with the Iowa Department of Public Health (Agency) Rules, and with the conditions of your license. The inspection consisted of a selective examination of procedures and representative records, observations, independent measurements, and interviews with licensee personnel.

No violations of Agency requirements were identified during the course of this inspection.

Chapter 136C.10, The Iowa Code, authorizes the Agency to establish and collect fees for the issuance and amendment of licenses for radioactive materials and the periodic inspection of radioactive materials. This rule is implemented through the establishment of a fee schedule, in accordance with 641-38.8(136C).

Your attention is directed to 641-38.8(2)"b" which requires that after completion of an inspection, a fee shall be assessed to a facility based on the fee schedule found in 10 CFR 170.31 entitled "Schedule of Fees for Health and Safety, and Safeguards Inspections for Materials Licenses," issued by the US Nuclear Regulatory Commission (NRC). This NRC fee schedule has been incorporated in the enclosed "Radioactive Materials Fee Schedule."

Based on your license category and the enclosed schedule, you have been assessed a fee of \$3,466.00 for the inspection conducted on July 20, 2006. The fee shall be paid within 30 days after receipt of this notification following the inspection and shall be made payable to the Iowa Department of Public Health.



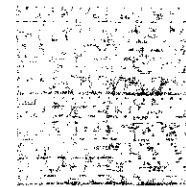
