As a point of clarification, these studies were not run concurrently, but rather the pH adjusted product study was conducted first followed by the non-pH adjusted product. In addition, the term "non-aqueous components" is equivalent to the term "active ingredients" as used to describe components of a product that serve a function in the end use application. However, it is not equivalent to the EPA FIFRA term that denotes a component with pesticidal activity.

From your communications to me, I understand that TVA 1) can not validate the pH adjusted test results, 2) does not concur with the non-pH-adjusted *C. dubia* chronic test results because of a large number of males in the test population and 3) however, does consider the results from the *C. dubia* test conservative and derived in a manner consistent with the EPA Methods manual.
