EQUIPMENT AND PERSONNEL LEASE AMENDMENT

This Equipment and Personnel Lease Amendment ("Amendment"), dated on or _____, shall be attached to and become a part of that certain Equipment and Personnel Lease ("Lease"), dated on or about October 21, 2003, between Atlantic City Medical Center ("Lessee"), and Digirad Imaging Solutions, Inc. 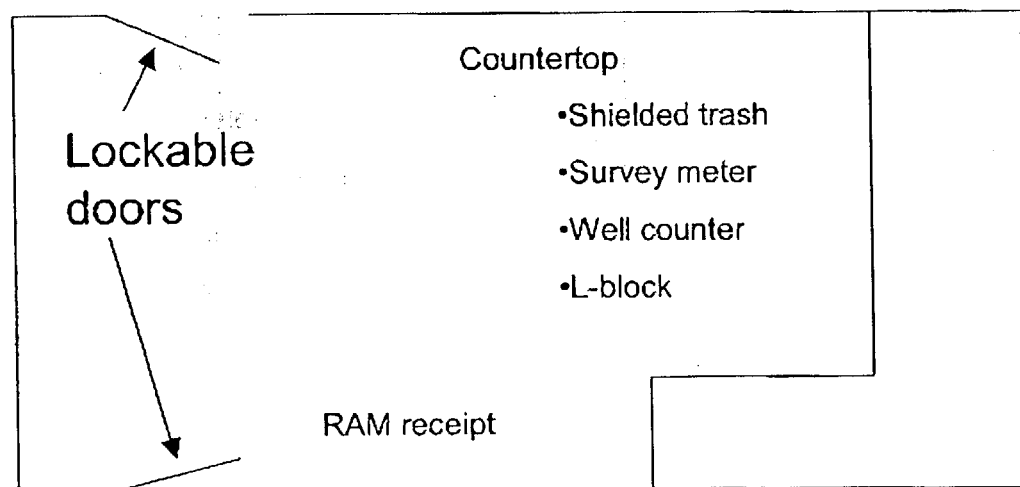

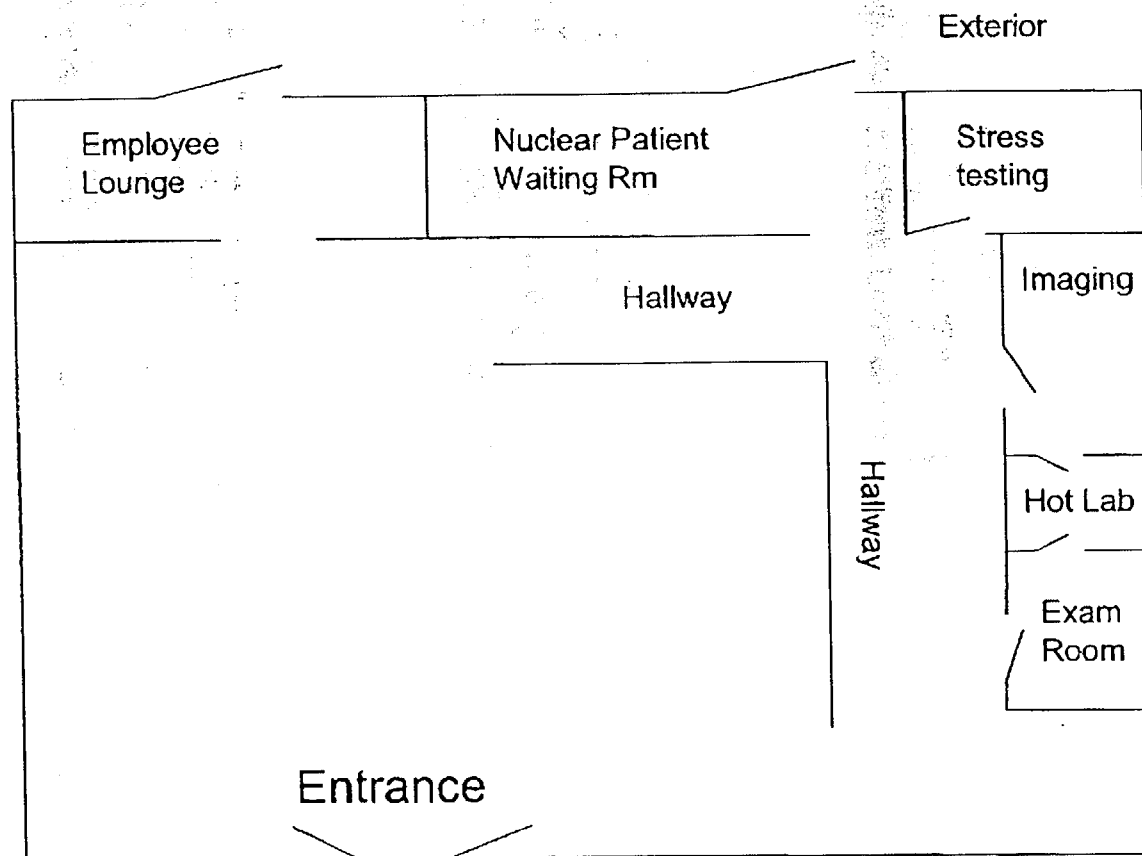
