Dear Mr. Young:

This is to acknowledge your letter dated July 10, 2006, providing NRC notification of the transfer of 246 sealed sources identified in Condition 6.B of License No. 29-19769-03 to the Barnwell, SC disposal site, in accordance with License Condition 14. The transfer activities performed by Steris Isomedix Services and your contractor, Energy Solutions, were inspected by Mr. C. Gordon on June 24-25, 2006. In their letter dated July 20, 2006 (enclosed), Energy Solutions notified the NRC that the shipping cask arrived at the Barnwell site on June 27, 2006, and was disposed of at the site on July 20, 2006. Also enclosed is NRC Form 591, "Safety Inspection," indicating that no items of non-compliance were found during the above described inspection of your licensed activities. Please retain the form in your files.
