Dear Dr. Moylan:

This letter forwards NRC Form 591, "Safety Inspection," which documents the results of the above described inspection and OI investigation of your licensed activities. The inspection was a review of activities authorized by your NRC license and the purpose of the OI investigation, based upon preliminary inspection findings, was to determine if Depleted Uranium (DU) was used in a willful manner not authorized by your license. Upon completion of the inspection, no items of non-compliance with NRC requirements were noted. With respect to the OI investigation; although OI determined that JCTO willfully removed DU from linear accelerators, upon further review, we have concluded that this use of DU was not prohibited by your license. Therefore, no violation occurred.
