The purpose of this unilateral modification is to provide incremental funding in the amount \$50,000.00, thereby increasing the total amount of funds obligated from \$233,000.00 to \$283,000.00. Accordingly, the following changes are hereby made:

"Task Order No. 005 shall be in effect from September 24, 2003, through September 23, 2006, with a total cost ceiling of \$330,396.00 for the total estimated reimbursable costs under the task order.

Incremental funds in the amount of \$50,000.00 are being obligated under this task order modification. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless, and until, the Contracting Officer increases the amount obligated with respect to this task order. Any work undertaken by the Contractor in excess of the obligated is done so at the Contractor's sole risk. Total funds obligated under this task order are \$283,000.00."

All other terms and conditions of the subject contract and task order remain the same.
