

The purpose of this modification is to: 1) extend the period of performance from July 12, 2006 to November 12, 2006, 2) increase the level of effort by 480 hours, and 3) obligate funds in the amount of \$36,000. Accordingly, the purchase order is modified as follows: The period of performance is revised to read: 07/12/2006 to 11/12/2006. The hours are increased by 480 from 536 to 1016 hours. The ceiling and obligated amount are hereby increased by \$36,321.60 from \$40,559.12 to \$76,880.72. All other terms and conditions of this purchase order remain the same. This modification obligates \$36,000.00.
