

The purpose of this modification is to: 1) Exercise Option Year 3 (October 1, 2006 – September 30, 2007), thereby extending the expiration date from September 30, 2006 to September 30, 2007. 2) Increase the ceiling amount of the delivery order by \$21,435.60 from \$60,391.20 to \$81,826.80. 3) Obligate funds in the amount of \$21,435.60 thereby increasing the obligated amount of the delivery order from \$60,391.20 to \$81,826.80.
